Thanks for inquiring about EWRG Club. Here is some general information about our Club:

**SKEET & TRAP FIELDS**

Hours of Operation:

Saturday, Sunday, Wednesday 12:30 pm - 6 pm

Cost: Members = \$3.00 per round / Non-Members = \$5.00 per round (1 round = 25 targets)

**NOTE:**

Skeet & Trap is open to Members and the General Public

**RIFLE & PISTOL RANGE**

Hours of Operation: Saturday, Sunday 9:00 am -12 pm (Check calendar for RO coverage)

Cost: Members without Pistol Pass = \$2.00 per visit / Members with Pistol Pass = \$40.00 per year

**NOTE:**

Rifle & Pistol Range is open to **MEMBERS ONLY!**

Guests are allowed under certain conditions only. See below for further explanation.

**GENERAL MEMBERSHIP**

Annual Dues: \$100.00 per year (Plus onetime fee of \$15.00 required with application).

General Members have access to the facilities, pay member prices for shooting (see above), and may vote at the annual Board of Director Elections meetings. General Members are allowed to use the R&P Range **ONLY** when it is open by a Range Officer.

**RIFLE & PISTOL PASS MEMBERSHIP UPGRADE (Key Card Access)**

Annual Dues: \$40.00 per year (in addition to the \$100 for General Membership above).

Key Card: \$5.00 (If lost or damaged there is a \$25 replacement/reactivation fee)

Once you have become a General Member (You must have your membership card in hand) you may sign up for our R&P Orientation course. Once completed, you may contact the Membership Secretary to apply for a Key Card, which will allow you access to the R&P Range during the days and hours that will be outlined in the course. Have your membership card and \$45.00 ready when applying.

**R&P GUEST POLICY**

- Members are allowed to bring a guest to the R&P Range **ONLY** when a Range Officer is present.
- There is a \$5 fee for the guest to shoot (in addition to the member fee, if applicable).
- Member is responsible for their guest at all times, and must supervise them while they are shooting.
- Member and guest must share one port, and one person can shoot at a time.
- Only **ONE** guest per member is allowed at any given time.
- Repeated visits by same guest(s) is discouraged. No more than 3 visits allowed.

1. Applications will be read at the next Board of Directors meeting immediately following receipt of the completed application along with full payment.
2. Once the application has cleared the first Board of Directors meeting, we will request a BCI check through the Attorney General's office.
3. Once we receive the BCI check, you will receive your membership card in the mail.

Boards of Directors Meetings are on the last Wednesday of each month.

Please be patient and remember that we are a 100% VOLUNTEER run club.

RELEASE AND AUTHORIZATION
